

Show Committee Meeting
November 8th, 2009

Meeting Called to order by Mike Green at 10:45 am

The minutes of the previous meeting were read and a motion was made to accept by Marleen and seconded by Mike.- motion passed.

Futurity – Entries were down from last year (See attached report) – People did visit the futurity stall, which Mike paid for personally. Mike sent the results to Karen and they are now on the website. Mike agreed to run the futurity again next year. Peggy suggested that Mike come up with a letter for potential sponsors.

Elmira – There was discussion about moving to Cobleskill, but the consensus was to keep the futurity show at Elmira at least for now. Erie County is also going to cover their ring and that should be done by next summer. Everyone should send their suggestions regarding footing, dragging, etc. to Mike and he will draft a list to send to Deloris so she can represent us at the Chemung Area Horse Council meeting to try to have improvements made. Mike also noted that we are getting charged for stalls that were use just briefly if a horse has eaten hay or pooped.... Lynn noted that we aren't collecting money to cover Rita's gas. Mike also thinks the stall fees are increasing.

NSBA – Gary said we really didn't make any money at the show. Only one non-palomino horse showed and the extra horses came from the other show that was on the grounds so we weren't able to collect any stall fees. NSBA requires we pay back 50% of the entries. Jen suggested that we put money into some of our own classes instead. Gary made a motion to not support NSBA for 2010, Renee seconded. Motion passed.

Elmira Fees – Renee suggested we go with one flat fee per horse/any division for classes. After much discussion it was agreed that a group would work on a proposal for the next meeting.

Parish – We lost a little money, so Shannon will gather all the fees so we can set new fees. Mike asked if we would consider moving to Palmyra. The grounds are right off the thruway. Has camper hookup... Wayne Co. Fairgrounds.

Show Program – Shannon noted that the 5-9 was before the adults and would like that changed so the kids go after, but have all their classes together.

BRVHA/NYPEA Fun Show – there was discussion regarding a clinic vs a fun show. Shannon will contact them to see what they want. Jen suggested we not continue to do what we've been doing.

Test & Tune – Paige & Peggy think it was a success. We made \$205 and the participants enjoyed it, so they will do it again.
